Updates on Case – Posted April - 2015



Firdaus Begum, CKD, Renal Transplant Case was posted this month and we are very thankful to our donors who once again showed extreme compassion and donated wholeheartedly. The transplant surgery is planned for first week of May 2015 as the patient had developed a severe lung infection for which she is being treated – we have earmarked Rs 5 lacs from the funds we have recvd for her and have also cleared the loans amounting to Rs 50000/- for the family.

Esophagus reconstruction with Colonic interposition done free at NIMS for a 20 yr old girl who weighed 20kgs



Rizwana Begum 20 yrs young girl had consumed acid in an attempt to commit suicide in 2011 – Her Oesophugal track was badly damaged and almost closed (Strictures) and she had become a mass of just bones weight 20kgs as she was not able to consume solid food. When this case was referred to us , we took this up thankfully rightly with our esteemed panel of Surgical Gastroenterologist at NIMS – Esophagus reconstruction with Colonic interposition was done to allow food to pass through and now by mercy of God in a massive 10 hrs surgery, she is on her way to recovery.

Disabled Child Support – covers over 40 children with Chronic Diseases & Thalassemia Major cases – Monthly out flow **Rs 80,000/-**

Physiotherapy for Patients – HHF has started Physiotherapy support to the patients who are young and on Bed Ridden, Two physiotherapist visits patients home, monthly expenses are **Rs. 25,000/-**

Disability Support for Bread winners – over 120 cases are registered and monthly **Rs 1,00,000/-** is marked for this.

Young Widows & Orphans Support – Over 60 cases are registered and HHF gives Rents, Pensions, School Fees – Monthly out flow **Rs 1,80,000/-**

Cancer & Kidney Support – covers patients who are finding no means to bear the medical expenses for treatment. In CKD cases monthly allowance of Rs 3000 per patient and all medical emergencies are covered.
