Sanjeeda Begum, 35 yrs case of Round Cell Maxillary tumor was posted this month for her treatment – However very tragically the patient expired after 2 rounds of chemo therapy not due to cancer but due to severe de hydration un related to Cancer. HHF guided and supported the family for the final rights as they are refugees with no local support and the funds which were collected for her will now go for other Cancer related cases with us.



Master. Abdul Qader C/o *lipomyelomeningocele* case was posted in the second half of this month and by the mercy of God his surgery was successful and the boy was discharged 3 days after the surgery HHF paid **Rs 1.8** lacs package amount for this.

Emergency Cases of Bread Winners



Brahmananda Reddy, 34 yrs, from Prodattur, Kudapah Dist was a private Bus Conductor and diagnosed with AVN Hip and also fell accidentally from first floor stairs and damaged the implant – he required 2nd time THR for which he was helpless as the govt funds are only given once - HHF have provided Implants of **Rs. 1,10,000/-** .



Shaik Yousuf, 44 yrs, Professionally a Blacksmith, is diagnosed with Tumour base of Tongue and surgery has been done at Omega Hospital and HHF have paid **Rs. 10,000/-**



Nadeem Ahmed, 26yrs, is an Embroidery worker, earns meagre, was suffering from Uretric Calculus and our empanelled doctor have done surgery at Goodwill Hospital for which HHF have paid **Rs. 20,000/-**

Disabled Child Support – covers over 65 children with Spasticity, CP & Thalassemia Major cases – Monthly out flow **Rs 80,000/-**

Disability Support for Bread winners – over 40 cases are registered and monthly **Rs 75,000/-** is marked for this.

Young Widows & Orphans Support – Over 115 cases are registered and HHF gives Rents, Pensions, School Fees – Monthly out flow **Rs 1,75,000/-**

Cancer & Kidney Support – covers all support for patients who are finding no means to bear the medical expenses for treatment. In CKD cases monthly allowance of Rs 3000 per patient and all medical emergencies are covered.
